Overview

At present, the economy and society have fully resumed normal operation, and the triple pressures of demand contraction, supply shock, and weakening expectations have been alleviated. The domestic economy has begun to stabilize and recover, and economic vitality is expected to be released at an accelerated pace. The trend of China's economic development in 2023 will be stable and progressing, with overall improvement. The resilience and vitality of economic development will be further reflected.

In 2022, China's crude steel production reached 1017.959 million tons, a year-on-year decrease of 1.7%; The production of pig iron reached 863.83 million tons, a year-on-year decrease of 0.8%; The total amount of steel scrap resources generated was 260 million tons, a year-on-year decrease of 10 million tons. The total consumption of steel scrap for steel making was 215.31 million tons, a year-on-year decrease of 10.9 million tons, a decrease of 4.8%. The comprehensive steel scrap ratio is 21.15%, a year-on-year decrease of 0.75 percentage points; The proportion of electric furnace steel was 9.71%, a year-on-year decrease of 0.99 percentage points.

In order to deeply implement the goal of carbon peak and carbon neutrality, persist in promoting the deep treatment and efficient utilization of metallurgical slag, and ultimately achieve zero emissions, the future steel scrap industry will rely on large steel enterprises, lead by demonstration bases for steel scrap processing and distribution, adhere to standard quality, strengthen standardized management, establish an orderly steel scrap processing and distribution system, and continuously improve the ratio of steelmaking scrap, create an innovative pattern for the ultra-low emissions and green and high-quality development of China's steel industry, and make new contributions.

Since its establishment in 2003, China International Metal Recycling Conference have been held for 14 successful sessions. The conference is an important platform for international exchanges and cooperation and further promoting the upgrading of metal recycling sector, pushing forward the development of ferrous and nonferrous metal recycling and utilization, advocating low carbon and green development concept.


